Your Re-registration is not completed until:

1. All information is completed on the re-registration form. If there is any change with the information supplied on your re-registration form from now until the time your child comes to school in September, please notify the office.
2. \$400.00 Academy fee per family is paid (non-refundable) for students in grades PK-8.
Academy Fee will be as follows:

Register before March 15th	\$300.00
Register from March 16th - April 15th	\$350.00
Register after April 15th	\$400.00
3. All health records and inoculations are up-to-date.
4. A copy of your child's birth certificate and certificates of sacraments (if you are Catholic) must be on file.
5. Uniforms are to be bought only at Lobel's Uniform Store, 5819 Bergenline Avenue, West New York, NJ. The more we support them - the more they support us.
6. Tuition is payable monthly to SAET from May through February. If the registration fee and May, June, July and August tuition are not paid, your child may not attend school in September.

Refund Policy Upon Withdrawal

The Academy fee is non-refundable under any circumstances.

If a child is registered, but does not start school in September, all monies paid to Tuition Program, Inc. are refundable, except the service fee charged by Tuition Program, Inc.

Once a child starts school, one monthly tuition payment is payable for each month or partial month the child is in school. The entire supply fee and Tuition Program, Inc. service fee are also payable.

For example: A student who withdraws on December 2nd would pay the following:

- September's tuition
- October's tuition
- November's tuition
- December's tuition
- Supply fee
- Service fee
